FOR PROPERTY OWNER(S) LOADING DEBRIS ON VILLAGE TRUCKS OVERNIGHT OR OVER A WEEKEND

In consideration of services to be rendered to the undersigned and other good and valuable considerations, the receipt of which are hereby acknowledged, the undersigned hereby releases and discharges the Village of Glendale, its agents and employees, against any and all liability, claims, demands, costs, damages and expenses of any kind, hereinafter the "claims" including, but not limited to, those arising out of the undersigned's use of the Village's property in and about the premises known as:

Whether or not such entrance and work are within the scope of the employment and agency.

The undersigned further agrees to hold harmless and indemnify the Village, its agents and employees, from any and all claims, including reasonable attorney fees, which the Village may incur as a result of allowing the undersigned to use Village property.

The undersigned represents that they are the owners of said premises, have invited the Village of Glendale, Ohio and its employees and agents upon the premises, and have the right to grant this release. This release shall be binding upon the undersigned, their heirs and assigns and agents.

A truck will be provided to the **property owner** of the above listed address for his/her use. Said truck may be used to load debris upon for disposal. Any construction debris loaded on a Village truck may be only from improvements made by the **property owner** at the above listed address and NOT as a result of work that has been performed by a contractor or by a resident at another address outside the Village of Glendale.

Owner agrees he/she shall not operate or otherwise move the vehicle or operate any equipment, which is accessory to the vehicle.

NOTE: If a Village vehicle (such as a dump truck) is loaded by a resident, the following items and materials MAY NOT be loaded onto the truck: NO hazardous materials of any nature, including but not limited to any: liquid paints, oil, batteries, tires, and appliances with Freon.

Furthermore, the undersigned property owner warrants and represents they have valid and adequate coverage and accepts financial responsibility for any and all damages which might occur to a Village owned vehicle during any period of time such vehicle is left at the premises of such property owner, at his/her request and for his/her convenience. Financial responsibility for such damage shall accrue to the property owner regardless of whether the property owner is directly responsible for the damage.
